

BOAT'S - REGULATIONS

Motorboat owners are kindly asked to collect from Reception at check-in the Lake Maggiore regulations, which must be kept on board. The vessel's registration number and the registration plate of your trailer will be taken at check-in.

Our staff will launch your boat according to a specific time schedule.

Boats of more than 2.5 metres in length must be issued with a specific identification mark from the province of Verbano Cusio Ossola.

It is advisable to obtain this before your visit; please therefore consult our website for all the relevant information and the exact procedure for obtaining the registration.

We advise you to insure your vessel with a policy that covers force majeure (severe storms, tornadoes, etc.). We also advise you to equip yourself with fenders (at least 4) and nylon mooring ropes, so that you can moor your boat correctly to the pier.



Boats measuring no more than 4 metres will be moored to the pier.

Boats over 4 metres will require the hire of a buoy.

It is obligatory to book a buoy or pier mooring, the buoy or the space at pier mooring is allocated by the reception, and it is absolutely prohibited to change places without prior authorisation or occupy other customer's place even for a short time.

Small motorised inflatable boats measuring less than 3.5 metres must be kept on the pitch and declared when booking.



The pier is not designed for diving

We therefore kindly request that guests only use it for mooring boats

A 'boat taxi' service operates from 10.30am to 06.00pm from the member of staff on duty at the beach will accompany our guests to their boats.

Please adhere to the return timetable.

Under no circumstances can motorised or non-motorised inflatables boats, canoes or SUPs be left on the beach or moored with DIY buoys.

Infringement of this regulation will authorise the beach manager to impound the vessel, as authorised by the Management.

Boat trailers must be taken to an appropriate partner facility situated 2km from the campsite, the address of which will be given to you at check-in.

The use of jet skis is restricted on Lake Maggiore.

The application must be presented to the Municipal office (except for the Municipal office of Verbania) in which the applicant is licensee to the buoy, berth, storage, habitual slipway, e.c.t or at the Province of Verbano Cusio Ossola, Via Industria n° 25, Gravelona Toce or by fax to n. +39-0323-4950369 or by email: nautica@provincia.verbania.it

A copy of the application must be kept on board the vessel and produced upon request as certification of mark application. It is the responsibility of the province of Verbano Cusio Ossola to issue the identification mark and nautical booklet within 30 days from the date the application is received.
